Eligibility, Nominations and Elections Guideline

Student elections are your opportunity to get involved, contribute and be a voice for AITC students!

Participation in student representation on the AITC Academic Board allows you to play a key role in student matters relevant to the Academic Boards responsibilities; furthermore, student representation also helps you to build a range of skills well regarded by employers.

Becoming a student representative may allow you to:

- Contribute to decision making at the Academic Board of AITC
- Represent student needs to the Academic Board of AITC
- Help create a more vibrant campus life
- Network with members at the Academic Board of AITC
- Discuss strategic issues with management

Elections

AITC conducts Elections foir Student Representation on Academic Board in accordance with this Guideline. Students must submit the AITC Student Representation Nominations Form to nominate themselves or a candidate of their choice.

AITC will hold an Election to fill Student Representation on the Academic Board when a position becomes vacant of a vacancy is due to occur when the current incumbent's term of office expires.

Timeframe

To fill a vacancy, other than a casual vacancy, AITC will open elections no sooner than 4 months and no later than 1 month before the current incumbent's term of office is due to expire. To fill a casual vacancy, AITC will open elections as soon as practicable before or after the casual vacancy occurs.

Nominations

After a call for nominations, if more than one valid nomination is received, AITC students will hold a vote. Students can submit the AITC Student Representation Nomincations Form in order to nominate themselves or a fellow student.

Eligibility for Membership

- 1. The Student Representative must, for the duration of the term of office, be a student
- 2. The Student Representative must not have been charged or alleged with any offence or breach of any of AITC's policies or procedures. This includes, but is not limited to:
 - a. Academic Misconduct
 - b. Non-Academic Misconduct

as defined by AITC's relevant policies.

- 3. No student may nominate for any position on any Student Representative Body if they have been previously removed from a position as a Student Representative for any reason related to their enrolment, including pursuant to these Procedures.
- 4. Unless specifically authorised by the AITC Academic Board, all student representatives must;
 - a. attend a compulsory induction hosted by AITC.

Votes

After nominations have closed, AITC's Student Cohor will be invited to vote for their preferred Student Representative through an online survey. Votes will be open for up to 2 weeks. AITC will release the result of the vote within 1 week from the closing date of votings.
